Shall the Board of Education of the Henry County R-1 School District, Missouri, without an estimated increase in the current debt service property tax levy, borrow money in the amount of Three Million Five Hundred Thousand Dollars (\$3,500,000) for the purpose of providing funds betterment of school facilities including, without limitation: to complete safety and security upgrades; to increase energy efficiency through replacement of roofs and heating, ventilation, and air conditioning (HVAC) systems; to complete electrical upgrades; to expand the agriculture program; to the extent funds are available, completion of other repairs and improvements to existing facilities of the district; and issue general obligation bonds for the payment thereof?

If this proposition is approved, the adjusted debt service levy of the School District is estimated to remain unchanged at \$0.5000 per one hundred dollars of assessed valuation of real and personal property.
